

# **NOTICE OF REFERENDUM**

## **WESTON AND BASFORD**

### **NEIGHBOURHOOD PLAN AREA**

## Referendum on the adoption of the Weston and Basford Neighbourhood Plan

1. A referendum will be held on **Thursday 16 November 2017** to decide the question below:  
  
**“Do you want Cheshire East Council to use the Neighbourhood Plan for Weston and Basford to help it decide planning applications in the neighbourhood area?”**
2. Applications to be included on the register of electors for this referendum must be received no later than **Tuesday 31 October 2017**.
3. Electors and their proxies should take note that:  
Any changes to, or cancellations of, existing postal or proxy vote records, and new applications to be treated as postal voters, must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **no later than 5.00pm on Wednesday 1 November 2017** if they are to be effective for this referendum. You must allow sufficient time for posted applications to be received in the Elections Office by the deadline.
4. All new applications for proxy voting arrangements must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **no later than 5.00pm on Wednesday 8 November 2017**, if they are to be effective for this referendum. You must allow sufficient time for posted applications to be received in the Elections Office by the deadline.
5. All applications to vote by emergency proxy at this election on the grounds of physical incapacity, or for work/service reasons, must reach the Electoral Registration Officer, either by hand at the Elections Office, Macclesfield Town Hall, Market Place, Macclesfield, Cheshire, SK10 1EA, or by post at the

Elections Office, Macclesfield Town Hall, c/o Municipal Buildings, Earle Street, Crewe, Cheshire, CW1 2BJ by **5.00pm on Thursday 16 November 2017** if they are to be effective for this referendum,.

You must allow sufficient time for posted applications to be received in the Elections Office by the deadline. The physical incapacity must have occurred after 5pm on Wednesday 8 November 2017. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday 8 November 2017.
